ACKNOWLEDGEMENT AND RELEASE OF LIABILITY

THE UNDERSIGNED DESIRES TO PARTICIPATE IN VARIOUS PROGRAMS, EVENTS OR ACTIVITIES (HEREIN COLLECTIVELY REFERRED TO AS "ACTIVITIES") OPERATED OR SPONSORED BY LIVING WATER EVANGELICAL CHURCH, (HEREINAFTER REFERRED TO AS THE "CHURCH"). THE UNDERSIGNED FURTHER UNDERSTANDS AND ACKNOWLEDGES THAT THE UNDERSIGNED, OR A MEMBER OF THE IMMEDIATE FAMILY OF THE UNDERSIGNED, MAY INCUR PERSONAL INJURY OR BODILY DAMAGE WHILE PARTICIPATING IN SUCH ACTIVITIES. THE UNDERSIGNED FURTHER UNDERSTANDS AND ACKNOWLEDGES THAT THE CHURCH WOULD NOT ALLOW THE UNDERSIGNED TO PARTICIPATE IN SUCH ACTIVITIES WITHOUT RELEASING AND HOLDING HARMLESS THE CHURCH. FURTHER, THE UNDERSIGNED REQUESTS THAT THE CHURCH ALLOW HIM/HER TO PARTICIPATE IN CHURCH ACTIVITIES, IN CONSIDERATION THEREOF AGREE TO HEREBY RELEASE, AND FOREVER DISCHARGE THE CHURCH, ITS OFFICERS AND DIRECTORS, AND ITS EMPLOYEES, THEIR AGENTS, AND PARTIES VOLUNTEERING ON BEHALF OF THE CHURCH FROM ALL ACTIONS, CAUSES OF ACTIONS AND CLAIMS DAMAGES OF ANY KIND GROWING OUT OF, OR RELATED TO ANY ACTIVITY OF THE CHURCH IN WHICH THE UNDERSIGNED PARTICIPATES. THE UNDERSIGNED FURTHER ACKNOWLEDGES THAT THIS IS A FULL AND COMPLETE RELEASE FOR ALL INJURIES AND DAMAGES THAT THE UNDERSIGNED MAY SUSTAIN AS A RESULT OF THE UNDERSIGNED'S PARTICIPATION IN THE EVENT INDICATED BELOW.

I DO CONSENT TO THE USE OF MY VOICE, LIKENESS AND PHOTOGRAPHIC OR VIDEOGRAPHIC IMAGE BY THE CHURCH AND, IN CONSIDERATION FOR PARTICIPATING IN THIS PROGRAM, I HEREBY GRANT THE CHURCH PERMISSION TO PHOTOGRAPH OR VIDEO MY IMAGE AND THAT OF MY MINOR CHILDREN PARTICIPATING IN SUCH PROGRAM AND CONSENT TO THE USE OF SUCH VOICE, LIKENESS, AND IMAGES BY THE CHURCH AND ITS EMPLOYEES, AGENTS, AND CONTRACTORS FOR ANY OR ALL CHURCH-SPONSORED COMMUNICATIONS (INCLUDING BUT NOT LIMITED TO, NEWSLETTERS, BROCHURES, WORSHIP FOLDERS, VIDEO PRODUCTIONS, CHURCH WEBSITE AND ADVERTISEMENTS) AND TO MAKE CHANGES OR ALTERATIONS TO SUCH VOICE, LIKENESS AND IMAGES AS THE CHURCH DEEMS PROPER. I ON BEHALF OF MYSELF, AM 18 YEARS OLD OR OLDER. I UNDERSTAND THAT MY SIGNED WAIVER WILL BE RETAINED IN THE CHURCH FOR 12 MONTHS. THIS DOCUMENT IS BINDING UPON ME AND MY HEIRS, CHILDREN, WARDS, PERSONAL REPRESENTATIVES AND ANYONE ELSE ENTITLED TO ACT ON MY BEHALF.

IF THE PARTICIPANT IS A MINOR (UNDER 18 YEARS OLD), I AGREE THAT THE MINOR HAS MY CONSENT TO PARTICIPATE IN THE EVENT. I FURTHER PROVIDE CONSENT FOR LIVING WATER EVANGELICAL CHURCH TO SEEK EMERGENCY TREATMENT FOR THE MINOR IF NECESSARY.
